



ORDER

- 1. The University vide notification No. 25499/2019/ AC1/GEN A2/KUHS dated 04.08.2021 had invited application from the institution affiliated to KUHS for granting Continuation of provisional Affiliation for the academic year 2022-23.
- 2. In response to the above notification, the Dental College listed below had submitted application with required documents and remitted necessary fee.
- 3. University conducted inspection in these colleges and the reports of the inspection were placed before the Scrutiny Committee meetings held on 05.04.2022 and 25.05.2022. The Scrutiny Committee after verification of the inspection reports and also the compliance reports (in case of the colleges having deficiencies) has recommended to grant Continuation of Provisional Affiliation to following 19 Dental Colleges to conduct the Dental UG and PG courses with the intake mentioned against each for the academic year 2022-23.
- 4. The recommendations of the Scrutiny Committee was placed before the Governing Council and the Governing Council vide decision read 2nd above has decided to grant Continuation of Provisional Affiliation to above colleges having recognition/renewal permission from apex council for conducting the Dental UG and PG courses for the academic year 2022-23.
- 5. In the circumstances, sanction is hereby accorded to implement the decision of the Governing Council read (2) above and to grant Continuation of Provisional Affiliation

ORDER

- 1. University vide paper read (1) above, had invited application for Continuation of provisional Affiliation for the academic year 2023–24 from the colleges for the courses affiliated to the university. In response to the same, the following 8 Dental Colleges listed in the table below had submitted application for continuation of Provisional Affiliation for conducting UG/PG courses in Dental Sciences, with necessary documents and remitted requisite fee.
- 2. As per clause II (4) of the Ordinance for the inspection in institutions for granting affiliation, "inspection for granting Continuation of provisional affiliation will be conducted every year till the first batch of the courses/enhanced seats in that institution is passed out. After that, inspection will generally be conducted once in two years provided the previous year's inspection report is satisfactory without any deficiencies."
- 3. On verification of the applications, it was found that these 08 dental colleges satisfy the above conditions for granting Continuation of Provisional Affiliation for the academic year 2023–24, without conducting inspection. Accordingly 72nd meeting of Governing Council, vide paper read (2) above resolved to grant Continuation of Provisional Affiliation to these 08 dental colleges for conducting UG/PG courses in Dental Science for the academic session 2023–24, without conducting inspection.



S.O. In exercise of the powers conferred by sub-section (2) of the section 11 of the Indian Medical Council Act, 1956(102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act:

In the said First Schedule after "Kerala University of Health Sciences, Thrissur" and under the heading 'Recognized Medical Qualification' [Hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration" [Hereinafter referred to as column (3)], the following shall be inserted, namely:-

Bachelor of Medicine and Bachelor of Surgery

M.B.B.S.

This shall be a recognized medical qualification when granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Al-Azhar Medical College Hospital, Super Specialty Thodupuzha with annual intake of 150 MBBS students on or after February, 2019.

- Note: 1. The recognition so granted to an undergraduate courses for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be
 - 2. The procedure for 'Renewal' of recognition shall be same as applicable for the award for recognition.
 - 3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned undergraduate Course.
