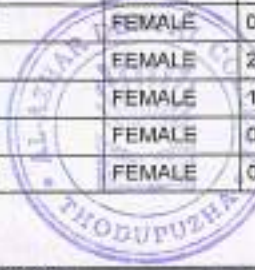

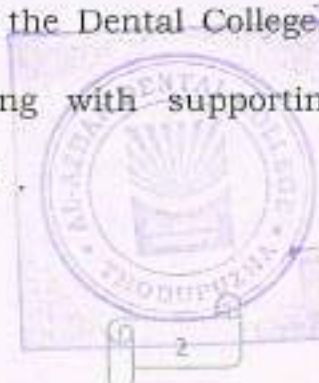

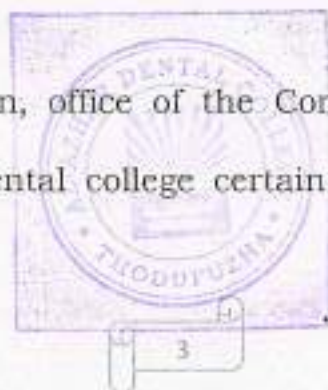

6. Accordingly, Mr.Latheef P M, PRO has submitted the list and supporting documents in respect of the Dental College on 14.09.2022. On scrutiny of the letter of permission and affiliation order issued by the Competent authorities, it is found that the Dental College is having intake strength of 100 BDS seats for the academic year 2021-22. The Dental College also has the privilege of being a Minority Institution. Therefore, the college authorities have submitted the certificate obtained from the National Commission for Minority Educational Institutions to prove their privilege of minority status.
7. 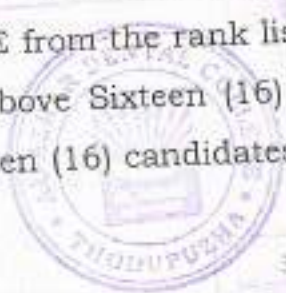

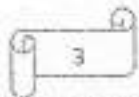

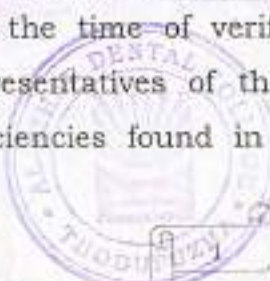

1. The Admission Supervisory Committee, herein after referred as the Committee, through communication dated 24.01.2020 has directed the Principal, Al Azhar Dental College, Thodupuzha, Idukki, in short the Dental College, to submit the list and supporting documents in respect of the admitted candidates of BDS Course for the academic year 2019-20, before the committee for approval.
2. The Principal of the Dental College has submitted the above documents through Mr. Vikash Viswanathan, PRO of the Dental College on 28.01.2020 on authorisation. At the time of verification of the documents in the presence of the representatives of the Dental College, the Committee pointed out the deficiencies found in the documents and directed the

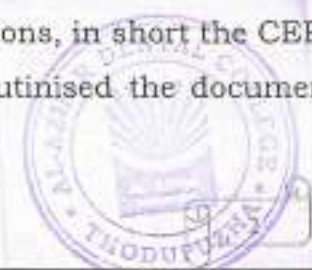

representative of the Dental College to submit relevant documents for curing the defects. Accordingly, the Principal of the Dental College through communication dated 05.02.2020 has submitted certain documents to establish the right of claim of admission.

3. The Committee scrutinised the list and supporting documents and found that the Dental College is having an intake strength of One Hundred (100) BDS Seats for the academic year 2019-20. The Dental College has submitted the recognition and Letter of Permission issued by the Competent Authorities to conduct the above course. The Dental College has also submitted that the provisional affiliation issued by the Kerala University of Health Sciences, in short KUHS. The Dental College is having Minority Status. The representative of the Dental College has also submitted the Minority certificate obtained from the National Commission for Minority Educational Institutions.
4. The Government of Kerala through order dated 08.07.2019 has approved the Seat Matrix for admission to the BDS Course in Self Financing Dental College Educational Institutions for the academic session 2019-20. The Committee has gone through the G.O and found that the Dental College has been sanctioned Fifty Five (55) seats under State Merit as per the Government reservation norms, Thirty (30) seats under Minority quota belong to Muslim Community and Fifteen (15) seats under NRI quota.
5. The Committee scrutinised the list and supporting documents submitted by the Dental College and found that the Dental College has admitted Sixty Seven (67) seats under State Merit as per reservation norms, Twenty Seven (27) seats under Minority quota belong to Muslim Community and Six (6) seats under NRI quota, as per allotment made by the Commissioner for Entrance Examinations, in short the CEE.
6. The Committee scrutinised the documents of Sixty Seven (67) candidates



admitted under State Merit as per the norms and found that the documents of Sixty Three (63) candidates are acceptable and the candidates are eligible for admission to BDS Course. Therefore, the admissions of the Sixty Three (63) candidates admitted under State Merit are hereby approved, as per the list shown in Annexure I.

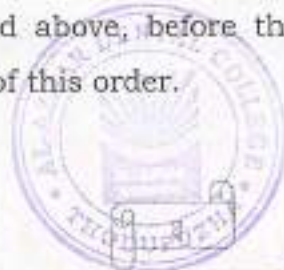

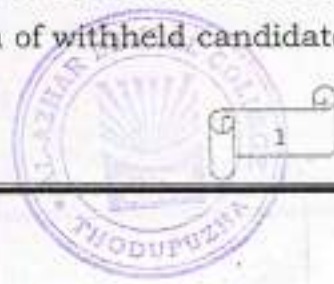


1. Order No. ASC 100/19/BDS/ADC dated 13.03.2020.
2. Communication No. AADC/VII/9/2020 dated 18.03.2020 from the Principal of Al Azhar Dental College, Thodupuzha.

ORDER

1. The Al Azhar Dental College, Thodupuzha, in short the Dental College, is having an intake strength of Hundred (100) seats for BDS Course 2019. The Admission Supervisory Committee, herein after referred as the Committee, by order dated 13.03.2020 has approved the admissions of Ninety Four (94) candidates and withheld the admissions Six (6) candidates under different categories for various reasons.
2. The Principal of the Dental College was directed to submit the relevant documents, as mentioned in the order dated 13.03.2020, before the committee within two weeks from the date of the order to cure the defects of withheld candidates.
3. Accordingly, the Principal of the Dental College through communication dated 18.03.2020 has submitted the documents to establish the right of claim of admission of withheld candidates.

On scrutiny of the documents, it is found that the NEET Score Card of the above Five candidates are acceptable and eligible for admission to BDS Course. ORDER

Sub: Order dated 28.06.2018 in WP(C) no. 19311 of 2018 of Hon'ble High Court of Kerala filed by the Chairman, Noorul Islam Trust & Al-Azhar Dental College, Kerala vs. Dental Council of India & ors.

Whereas, DCI vide letter dated 29.12.2017 recommended to this Ministry "not to renew" its permission for admitting 5th batch and "not to allow" the admissions at the college with increased intake capacity from 50 to 100 seats for the academic year 2018-19.

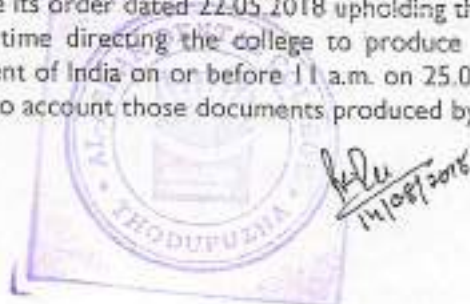
2. Whereas, this Ministry afforded a personal hearing to the dental college on 17.01.2018 u/s 10A(4) of the Dentists Act, 1948. This Ministry sent the scheme to DCI for reconsideration with following observation of the Hearing Committee:

"The Committee is in agreement with the recommendation of the DCI that the renewal permission shall not be granted when the Bank authorities has issued notice for initiating recovery proceedings including attachment of land/building. However, since the college representative submits that they have made partial repayment of Bank dues and will seek time from the bank authorities to deposit the remaining dues, the Hearing Committee recommends the scheme to DCI for reconsideration, if the college is the able to produce adequate documentary proof to DCI directly."

3. Whereas, in the meantime, the Hon'ble High Court of Kerala vide order dated 21.04.2018 in WP(C) no. 8393/2018 while disposing the matter stated that the petitioner (i.e. Al-Azhar Dental College) was not entitled to get any relief as is sought for in the WP, there being no arbitrariness, illegality or unfairness on the part of the 1st respondent (i.e. DCI) in taking action against the petitioner. Further, the court stated that if the college made any application/representation with sufficiently financial security like Bank Guarantee, additional documents or cleared the transaction under question, DCI might consider for a final decision.

4. Whereas, DCI vide its letter dated 27.04.2018 stated that no such representation was received from the college till then and the Executive Committee of DCI, in the best interest of the students and to protect them from jeopardizing their career in case of attachment of property of the college by its banker recommended for non-renewal of 5th batch in BDS course with increased intake from 50 to 100 seats for AY 2018-19 and also recommended for "stoppage of admission" in BDS courses for the academic session 2018-19 and the college shall not admit any student in BDS course from the academic session 2018-19 onwards till the matter of recovery of loan is finally settled with the bankers.

5. Whereas, the College filed Writ Appeal (WA) no. 949/2018 against the judgment in WP (C) no. 8393/2018 of the High Court of Kerala dated 21.04.2018. The court disposed of the appeal vide its order dated 22.05.2018 upholding the judgment of the learned single Judge, but at the same time directing the college to produce the original documents and clarifications to Government of India on or before 11 a.m. on 25.05.2018 and directed the Government of India to take into account those documents produced by the appellants while passing orders.

6. Whereas, in pursuance of the above order dated 22.05.2018 of High Court of Kerala, the college vide letter dated 24.05.2018 has submitted their clarification and certain related documents on 25.05.2018 requesting this Ministry for renewal permission of BDS scheme with increased intake from 50 to 100 seats for the academic year 2018-19.

7. Whereas, it was found that the college had not submitted any original/authenticated documents in support of their claims for permission of 5th year BDS course from 50 to 100 seats for AY 2018-19. No proof could be submitted by the college indicating that repayment had been made by them/recovery proceedings had been dropped by the Bank.

8. Whereas, this Ministry vide order dated 30.05.2018 decided to accept the DCI's recommendation dated 27.04.2018 for non-renewal of 5th batch in BDS course with increased intake from 50 to 100 seats for AY 2018-19 and "stoppage of admissions" in BDS courses for the academic session 2018-19. It was further conveyed that "the college shall not admit any student in BDS course from the academic session 2018-19 onwards till the matter of recovery of loan is finally settled with the bankers".

9. Whereas, the college filed W.P(C) no. 19311 of 2018 in the Hon'ble High Court of Kerala and the Hon'ble Court passed the following order dated 28.06.2018:

".....In the above view of the matter, I am of the opinion that while upholding the decision in Ext. P10 with regard to withdrawal of letter of permission for intake of the additional 50 students, the petitioner is entitled to make admissions to the 50 seats which has recognition as per Exts P2 and P3. The contentions of the parties on the merits of the matter are left open. The respondents will be free to take action in accordance with law with regard to the withdrawal of recognition, if so advised"

10. Whereas, Debts Recovery Tribunal proceedings dated 26.06.2018 in I.A. no. 1440/2018 in SA no. 247/2018, inter alia directed as under:

"..... directs the respondent bank to defer taking coercive possession if and only if a sum of Rs. 1,50, 00, 000/- (Rupees one crore Fifty lakhs only) is paid by the petitioners into the loan account on or before 03.07.2018. on the petitioners' non-compliance of the above for reasons whatever it be, the respondent bank would be free to surge ahead with its already initiated SARFAESIA measures of course in accordance with law. Call on 10.07.2018 for reporting compliance and for advancing of final arguments in the SA."


11. Whereas, the college vide its letter dated 30.06.2018 claimed that they have paid the amount of Rs. 150 crores in compliance to the above order dated 26.06.2018 of Debts Recovery Tribunal. They requested this Ministry to issue the LOP for AY 2018-19 and also to revoke recommendation for stoppage of admissions.

12. Whereas, DCI filed an LPA no. 1568/2018 in the Hon'ble High Court of Kerala and the Hon'ble Court vide judgement dated 30.07.2018 has passed the following, while dismissing the LPA as under:

".....8. Therefore as was rightly noticed by the learned Single Judge, the action proposed in the ext. P10 was not warranted, for stoppage of 50 seats, which already had the requisite recognition for last several years as per Exts.P2 and P3. In any case, the liberty to take necessary action as may be found warranted, is available with the authorities. Moreover, the Dental College, as it appears, have made peace with their Bankers at whose instance, the impugned proceeding was started by the DCI.

9. In the above circumstances, we see no infirmity in the judgement in appeal. Hence, the appeal by the DCI is found devoid of merit and the same is thus dismissed"

13. Whereas, DCI vide its letter dated 03.08.2018 has agreed to allow 50 seats in BDS course for academic session 2018-19, since the college is recognised with 50 seats. As per the order dated 28.6.2018 of the Hon'ble High Court, the Court upheld the decision of Ministry dated 30.5.2018 with regard to the non-renewal of permission in the increased intake from 50 to 100 seats and the college is entitled to make admissions to the 50 seats which are already recognised.

14. In view of the above, this Ministry has decided to allow admissions of 50 recognised seats in BDS course for academic session 2018-19 in pursuance of the Hon'ble High Court of Kerala's order dated 28.06.2018 in W.P(C) no. 19311/2018. However, it is also conveyed that Ministry's order dated 30.05.2018 with respect to "non-renewal of 5th batch in BDS course with increased intake from 50 to 100 seats for AY 2018-19" shall remain in force.

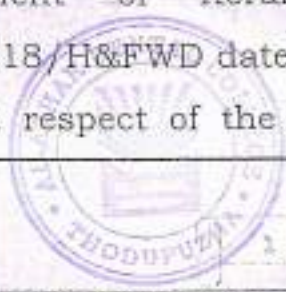

The Dental College has also submitted the Minority Certificate issued by the competent authorities to establish their minority rights to take admission under Minority quota.

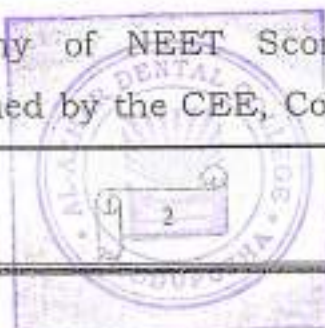
2. The Government of Kerala through G.O (Rt) No. 2236/2016/2018/H&FWD dated 11.07.2018, has approved the seat matrix in respect of the KMCT Medical College and Al

Azhar Dental College to MBBS and BDS Courses for the Academic year 2018-19. As per the seat matrix, the Commissioner for Entrance Examinations (CEE) has to allot 27 seats under Open category, as per the State reservation norms, 15 seats under Minority quota belonging to Muslim Community and 8 seats under NRI quota to Al Azhar Dental College, Thodupuzha for the academic year 2018-19.

3. The Principal of the Dental College has submitted the list of admitted candidates and supporting documents of BDS candidates through Mr. Vishakh Viswanathan, PRO of Dental College on 22.12.2018. At the time of verification of documents the committee pointed out certain deficiencies in the certificates submitted by the Dental College. The Principal of the Dental College through communication dated 27.12.2018 has resubmitted all the documents and rectified deficiencies pointed out by the committee.
4. The Admission and Fee Regulatory Committee, in short AFRC, has scrutinised the entire documents relating to the BDS Course submitted by the Dental College with the CEE registration list and KUHS Registration report. On scrutiny of the documents, the Committee found that the Dental College has admitted 33 candidates under open category, 15 candidates under Minority category and 2 candidates under NRI category for BDS Course during the academic year 2018-19.
5. On detailed scrutiny of NEET Score cards, Data Sheet, allotment memo issued by the CEE, Community certificate and



other supporting documents of 33 candidates admitted under Open quota category, it is found that the documents of 33 candidates are acceptable and eligible for admission to BDS Course under open category. Therefore, the admissions of 33 candidates under open category are hereby approved.


6. The Committee has scrutinised the documents including community certificates of 15 candidates under Muslim Minority category and found that the documents of 15 candidates are acceptable and have established that they belongs to Muslim Community. Therefore, the admissions of 15 candidates under Minority quota are hereby approved.

7. The Dental College has submitted the list of 2 admitted NRI candidates and supporting documents under NRI quota.
